It provides a license to use our Sound Recordings and/or Packs and contains warranty information and liability disclaimers.

DEFINITIONS:

Sound Recordings: referring to any audio files included within "Packs" products and/or within "other" products.

Packs: referring to any and all Sound Recordings, bundled in Packs or other Products.

Licensor: referring to Oddiction Media who set the terms of this license.

Licensee: referring to the end user who agrees to all the terms of this license.

If you download a free trial of our Sound Recordings and/or Packs, this EULA agreement will also govern those. By downloading all or any portion of our Sound Recordings and/or Packs included in our products, you accept all the terms and conditions of this EULA agreement.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not download, install or use our Sound Recordings and/or Packs, and you must not accept this EULA agreement.

• Share or store the Sound Recordings and/or Packs on a public server, streaming server or torrent site, without the express permission from the Licensor (Oddiction Media).

THE LICENSEE MAY:

SINGLE-USER MEDIA PRODUCER LICENSE:

An individual purchase of one product will grant you the personal license to use one or more versions of this product to its full extent, including the royalty-free use of all assets in your productions, recordings and/or performances. You are legally prohibited to distribute, lend, rent or sell your copy of any products in whole or in part.

- Oddiction Media grants the Licensee the non-exclusive right to use the purchased Sound Recordings and/or Packs as part of their media productions in whichever medium they choose.
- Synchronization Rights: Oddiction Media grants the Licensee the nonexclusive right to use the purchased Sound Recordings and/or Packs as a soundtrack synchronized with visual images, games, or theatrical works.

It will also terminate immediately if you fail to comply with any term of this EULA agreement.
